



## HOW TO FIND OUT IF ANY AREA LIES WITHIN MORPHOLOGICAL RIDGE OF DELHI OR NOT?

- 1. Prepare *kml* file of the concerned area.
- 2. Log in to <a href="https://evanlekh.eforest.delhi.gov.in/">https://evanlekh.eforest.delhi.gov.in/</a>
- 3. Go to Ridge on the top vertical row and when you bring the cursor on this "Morphological Ridge" in blue will appear as follows:




4. Click on "Morphological Ridge" and following will appear:



The area marked by yellow boundary the 'Morphological Ridge' as per map provided by Geological Survey of India (GSI).


5. Just above this Google Earth image you can see a box in the left hand side with wordings "Upload KML file".

6. Please upload the *kml* file of your project site. For example, a kml of proposed building of NDRF has been uploaded and the following emerged:



7. The blue dots indicate location of the site whose kml has been uploaded. As can be seen it falls within the Morphological Ridge area.

8. In some cases, the area may partly fall inside the Morphological Ridge and partly outside. You can find that out by enlarging this image using + and – signs on the left top corner of the map. The image in the current selection will come out as follows, and the entire area in this case lies within the boundaries of Morphological Ridge:



9. The process is simple and gives objective results very quickly. The CEC is also using the same process for analyzing the projects submitted before it.
